SECOND AMENDMENT TO  
DECLARATION OF HORIZONTAL PROPERTY REGIME  
MAKAHA SURFSIDE

WHEREAS, PROJECT COORDINATOR'S OFFICE, INC., a Hawaii corporation, General Partner of MAKAHA SURFSIDE DEVELOPMENT COMPANY, a Hawaii registered limited partnership, as owner, did submit to the provisions of Chapter 514, Hawaii Revised Statutes, as amended, those certain parcels of land more particularly described in Exhibit "A" of the Declaration of Horizontal Property Regime - Makaha Surfside, (hereinafter called the "Declaration"), by the filing of said Declaration dated November 28, 1972 with the office of the Assistant Registrar of the Land Court of the State of Hawaii as Land Court Document No. 608328; and

WHEREAS, said Declaration was amended by instrument dated December 11, 1973, and filed in said Office of the Assistant Registrar of the Land Court of the State of Hawaii as Land Court Document No. 660872; and

WHEREAS, pursuant to Article 16.0 AMENDMENT OF DECLARATION, of said Declaration, the same may be further amended by vote of the owners whose interest in the common elements of the project total in the aggregate not less than seventy-five per cent (75%); and

WHEREAS, it is the desire and intention of the necessary quorum of the owners as noted above, to amend said Declaration as the same relates to "Laundry Buildings";

NOW, THEREFORE, the said Declaration dated November 28, 1972 and filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii as Land Court Document No. 608328, as amended by instrument dated December 11, 1973, and filed as aforesaid as Land Court Document No. 660872, and noted on the Transfer Certificate of Title listed on Exhibit "1" attached hereto and by reference incorporated herein is hereby amended as follows:

1. Article 1.1 DESCRIPTION OF GROUNDS., of said Declaration shall be amended by the deletion therefrom of the words "laundry building" wherever used therein, and the insertion therefor of the words "Convenience Service Center."

2. Article 2.32 LAUNDRY BUILDINGS., shall be amended by the deletion therefrom of the words "laundry building" or "laundry buildings," wherever used therein, including the use of such words in the topical heading of said paragraph, and the insertion therefor in each such place of the words "Convenience Service Center" or "Convenience Service Centers," whichever shall be applicable.

3. Article 2.5 COMMON ELEMENTS., sub-paragraph b., shall be amended by the deletion therefrom of the words "laundry buildings," and the insertion therefor of the words "Convenience Service Centers," wherever used therein.

4. Article 3.0 PERCENTAGE OF UNDIVIDED INTEREST IN THE COMMON ELEMENTS., sub-paragraph a., shall be amended by the deletion of the words "laundry building" and the substitution therefor of the words "Convenience Service Center," wherever used therein.

5. Article 4.0 EASEMENTS., shall be amended by the deletion of the words "laundry building" and the substitution therefor of the words "Convenience Service Center", wherever used therein.

6. Article 5.0 ALTERATION AND TRANSFER OF INTEREST., shall also be amended by the deletion of the words "laundry building" and the insertion in place thereof, of the words "Convenience Service Center", wherever used therein.

7. Article 7.0 ASSOCIATION OF OWNERS., shall be amended by the deletion of the words "laundry building" or "laundry buildings", and the insertion in place thereof, as applicable, of the words "Convenience Service Center" or "Convenience Service Centers", wherever used therein.

8. Article 9.0 COMMON EXPENSES., shall be amended by the deletion of the words "laundry building" or "laundry buildings", and the substitution therefor of the words "Convenience Service Center" or "Convenience Service Centers", whichever shall be applicable, wherever used therein.

9. Article 10.0 COMPLIANCE WITH DECLARATION, BY-LAWS AND DECISIONS., shall be amended by the deletion of the words "laundry building" and the substitution therefor of the words "Convenience Service Center", wherever used therein.

10. Article 11.0 INSURANCE., and all sub-paragraphs thereof shall be amended by the deletion of the words "laundry building" or "laundry buildings" wherever used therein, and

the substitution therefor in each such place of the words "Convenience Service Center" or "Convenience Service Centers", whichever shall be applicable.

11. Article 12.0 CONDEMNATION., shall also be amended by the deletion of the words "laundry buildings", and the substitution therefor of the words "Convenience Service Centers", wherever the same shall appear therein.

12. Article 13.0 UNINSURED CASUALTY., shall be amended also by the insertion of the words "Convenience Service Centers", in place of the deleted words "laundry buildings", in all places where said words shall appear.

13. Article 15.0 MAINTENANCE RESERVE FUND., shall be amended in the same manner by the substitution of the words "Convenience Service Center", in place of the deleted words "laundry building", in all places where the same shall appear.

14. Article 19.0 DEFINITIONS., shall be amended by the deletion of the words "laundry building", or "laundry buildings", or "Laundry Building Owner", and the substitution therefor of the words "Convenience Service Center", or "Convenience Service Centers", or "Convenience Service Center Owner", whichever shall be applicable in each instance, and wherever the same shall be used therein.

15. In all other respects, the Declaration, as previously amended by instrument dated December 11, 1973, and filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii as Document No. 660872, is hereby ratified and confirmed and shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors and assigns

and all other persons now or at any time hereafter owning or leasing all or any part of the Project and their respective heirs, executors, administrators, successors and assigns.

16. This Second Amendment shall take effect upon the execution and filing hereof in the Office of the Assistant Registrar of the Land Court of the State of Hawaii.

IN WITNESS WHEREOF, this Second Amendment has been executed by all of the members of the Board of Directors of the Association of Owners of Makaha Surfside, on behalf of said Association of Owners, by authority of the vote of not less than seventy-five per cent (75%) of the owners' total interest in the common elements of the Project, on this 2nd day of June, 1978.
